The data products MEMX offers include:

- a) **MEMOIR Depth.** MEMOIR (MEMber’s Order Information Record) Depth is a data feed that contains all displayed orders for listed securities trading on the Exchange,

order executions, order cancellations, order modifications, order identification numbers, and administrative messages.

- b) **MEMOIR Top.** MEMOIR Top is an uncompressed data feed that offers top of book quotations and execution information based on equity orders entered into the System.
 - c) **MEMOIR Last Sale.** MEMOIR Last Sale is an uncompressed data feed that offers only execution information based on equity orders entered into the System.
